Abigail Averbach serves as Assistant Commissioner and Director of the Office of Population Health for the Massachusetts Department of Public Health (DPH). In this role, Abigail oversees the Office of Data Management and Outcomes Assessment, Special Analytics Projects, Office of Health Equity, and the Registry of Vital Records and Statistics. She oversees the Public Health Data Warehouse, a nationally recognized innovation that underlies the Department's efforts to address inequities in health outcomes. Amy is responsible for the Population Health Information Tool (PHIT), an interactive webbased data portal designed to support community health planning, using a health equity framework with a focus on the social determinants of health.

Prior to joining DPH in 2017, Abigail served as Assistant Vice Chancellor, Chief of Staff and Director of the Office of Data Analytics at UMass Medical School's (UMMS) Commonwealth Medicine Division. She was Chair and member of the Worcester Board of Health for over a decade and served on the Community Outreach Committee of the Health Foundation of Central Massachusetts.

Abigail holds a Masters of Science degree in Public Health (Epidemiology) and a faculty appointment in the Department of Family Medicine and Community Health at UMMS.



Doug Brown is President of UMass Memorial Community Hospitals and Chief Administrative Officer for the UMass Memorial Health Care system. UMass Memorial is a \$2.4 Billion integrated health care delivery system in Central Massachusetts with over 13,000 employees. The system includes approximately 30 corporate entities, including an academic medical center, 2 community hospitals, a large physician group practice and numerous related entities. It is the clinical partner of the University of Massachusetts Medical School.

In his current role, Doug has a wide range of system responsibilities, including oversight of UMass Memorial's two community hospitals, its

behavioral health provider, and oversight over several system corporate functions, including human resources, legal affairs, governance, compliance, internal audit, government affairs, and health policy and public programs. He also currently leads the system's anchor mission work.

Doug has a breadth of experience in both the private sector, where he worked at two large law firms, and the public sector, where he served in leadership roles in two separate branches of Massachusetts state government. These roles included service as an Assistant Attorney General, as General Counsel of the Senate Committee on Ways and Means, and finally as Director of the state Medicaid program in 2003 before coming to UMass Memorial.



Sandro Galea, MD, MPH, DrPH a physician, epidemiologist, and author, is dean and Robert A. Knox Professor at Boston University School of Public Health. He previously held academic and leadership positions at Columbia University, the University of Michigan, and the New York Academy of Medicine. He has published more than 800 scientific journal articles, 50 chapters, and 15 books. His latest book is "Well: What We Need to Talk About When We Talk About Health"; Arianna Huffington has called it "A deeply affecting work

from one of the important and innovative voices in American health and medicine". Sandro holds a medical degree from the University of Toronto, graduate degrees from Harvard University and Columbia University, and an honorary doctorate from the University of Glasgow. Sandro was named one of Time magazine's epidemiology innovators and has been listed as one of the "World's Most Influential Scientific Minds." He is chair of the board of the Association of Schools and Programs of Public Health and past president of the Society for Epidemiologic Research and of the Interdisciplinary Association for Population Health Science. He is an elected member of the National Academy of Medicine. Sandro has received several lifetime achievement awards. He is a regular contributor to, and his work is regularly featured in, a range of public media.

Nissa James, Ph.D., dedicated her undergraduate studies to behavioral neuroscience after discovering that mental and physical health were intricately intertwined as an undergraduate student. Her undergraduate studies in neuroscience ignited a spark within her for further understanding and the subsequent need for amassing additional knowledge led to the pursuit and attainment of a Doctor of Philosophy degree in Pharmacology and Toxicology in 2006. Dr. James strived to understand the physiological processes that influence human behavior and published in peer-reviewed literature on her work in investigating the effects of nicotine exposure during crucial periods of development in animal models. After traveling all over Europe, Dr. James joined a clinical research organization to further her understanding of the considerations for human participant involvement in clinical research. During that time, she recognized the substantial impact of the social determinants of health for the participants in her studies and returned to her roots in practicing a community-development approach to the prevention of chronic conditions as a result.

Dr. James joined the Blueprint for Health in 2017; the Blueprint for Health is Vermont's state-led program within the Department of Vermont Health Access for integrating a system of health care for patients, improving the health of the overall population, and improving control over health care costs by promoting prevention, health maintenance, care coordination and care management. In 2019, Dr. James became the Director of Communications and Legislative Affairs for the Department of Vermont Health Access (DVHA); DVHA is the state department that administers the Vermont Medicaid program.



Phillomin "Philly" Laptiste is the Executive Director of Bowdoin Street Health Center (BSHC), a community health center in the Bowdoin-Geneva neighborhood of Dorchester that operates under the licensure of Beth Israel Deaconess Medical Center (BIDMC).

A second-generation Bowdoin-Geneva resident, Philly graduated from Boston Latin School, received her bachelor's degree in management and organizational communications from Emerson College, and completed a master's degree in health care administration at Suffolk University. In June 2015 she graduated with a certificate from the Massachusetts Institute for Community Health Leadership, one of

only 19 professionals in the state to participate in this program.

Philly joined BSHC in 2008 as the manager of community health, where she was responsible for developing and implementing community health programs and serving as a liaison to the community. She then went on to become an operations manager for practice and community health at BSHC and continued to take on increased levels of responsibility while ascending to her role as associate director. In her current role, Philly oversees health center operations and develops, implements, and evaluates health center programs in response to changing community and patient needs. She supervises BSHC's administrative staff, medical staff, and nursing management, and manages all external relationships and marketing efforts. She also played an integral role in the establishment of the Wellness Center at BSHC.

Philly has committed her time to numerous community building and neighborhood improvement events. She is passionate about improving the well-being of the neighborhood and the people who live within it. In addition to being the co-chair of both the Bowdoin Geneva Alliance and Friends of Geneva Cliffs, she has participated in Boston Shines neighborhood clean-up events, community gardening clean-up days, and the oversight of the annual "Haunted Forest at the Cliffs," event to create a safe Halloween for neighborhood youth and their families. She constantly instills the importance of giving back to the community in her colleagues and her family.

Philly ran the Boston Marathon for Team BIDMC in 2017 and again in 2018. In 2018, she was recognized by BIDMC as a YMCA Achiever for her accomplishments and dedication to community service. Under her leadership, BSHC received the Mayoral Prize Award for Innovations in Primary Care. Most recently, she was appointed as one of seven Commissioners to the Board of Health for the city of Boston. In this role, Philly works on a broader scale to impact change and ensure equity in health outcomes for residents throughout the City of Boston. As an adjunct professor for the Suffolk University Healthcare Administration Program, she is also a member of the program's Advisory Board. Philly served on the Transition Team for Suffolk County District Attorney Rachael Rollins and is currently serving as part of the Discharge Integrity Team.

Daniel Slater, MD is the Chair of Pediatrics and the Medical Director, Mass Health ACO at Atrius Health. Dr. Slater is an Adjunct Staff at Boston Children's Hospital and Assistant Professor of Pediatrics, Part Time, Harvard Medical Schoo .
